# Early Constraints & Barriers



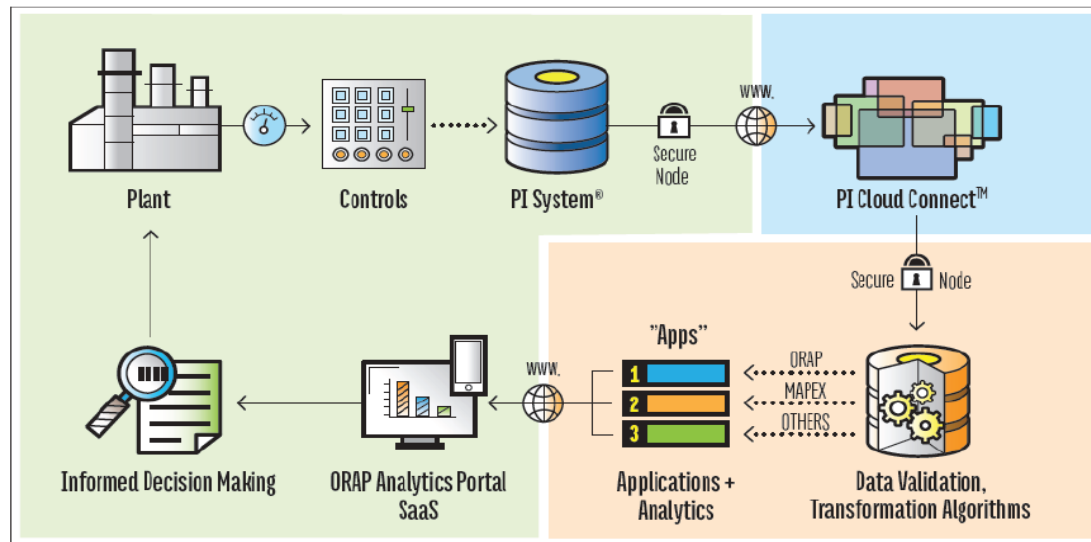
- Hardware & Software – Local to Site
- Onsite Installation - Custom Configuration
- Many different interfaces (Modbus, OPC, etc.)
- Dedicated VPN Required
- Lots of “Care and Feeding”
- Expensive to purchase and maintain

- Solution = GADS “app”

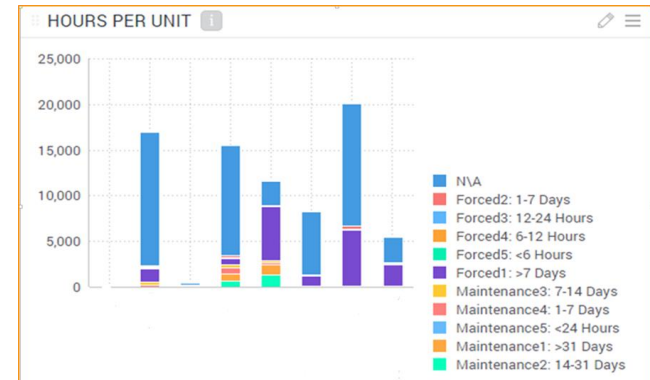

- US Owner/Operator
  - 3 sites with HDGTs & ST's
- Manually Tracking Parts Life in Excel
  - Limited Access to Records
  - Inventory value overstated by ~\$5M
- Solution = Life Calculator “app”

*All Capital Hot Gas Path Parts Life Tracked at a Serial Number Level  
ROI <1 Year*
